	Correctional Officer Eric Hall reported on March 17, 2020, at approximately 5:58 a.m., he was assigned to the Florida State Prison West Unit conducting the search of all staff entering the facility. The area he was conducting the search was inside of the secure perimeter fence of the Florida State Prison West Unit. Sergeant Hall was searching several officers and upon the completion of a pat search of another staff member, he observed a large clear wrapped package lying on the floor next to the metal detector. He picked the package up, unwrapped the saran wrap, and observed a vacuum sealed clear wrapped plastic bag that contained a green leafy substance. He notified the shift supervisor.  Correctional Officer Captain Brian Starling reported that he received the package containing the green leafy substance that was discovered by Officer Hall. Captain Starling reviewed the fixed wing video system and saw the package recovered fall from the pant leg of Officer Kevin Johnson onto the floor.  Your Affiant and Senior Inspector Kevin Ortiz responded to the Florida State Prison West Unit. Based on Your Affiant's training and experience, the substance was identified as Cannabis/Marijuana. It weighed approximately 34 grams. Correctional Officer Kevin Johnson waived his Constitutional Rights
