The Undersigned Certifies and swears that he has just and reasonable grounds to believe and does believe that the above-named Defendant committed the following Violations of the law: §944.35(3)(a)(1), Malicious Battery of an Inmate, which occurred on May 23, 2018. 04:26 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector James Padgett with the Office of the Inspector General - DC.

Your Affiant has probable cause to believe, on May 23, 2018, Sergeant Jarod Michael Canaday, Officers Travis Ian Hall, and Robert Fetter Jr. committed the criminal offense of; Malicious Battery of an Inmate; when, Sergeant Canaday, Officers Hall and Fetter, maliciously battered Inmate [REDACTED] at which time, Inmate [REDACTED] was restrained behind his back with handcuffs and leg irons on his ankles, by striking Inmate [REDACTED] on or about his body utilizing their hands and feet, [REDACTED] to the person of Inmate [REDACTED], to include but not limited to: [REDACTED] due to the improper application of restraints [REDACTED]

Inmate [REDACTED] was escorted from confinement on May 23, 2018, by Sergeant Canaday, Officers Hall and James Lee to the [REDACTED] for possible K-2 intoxication and [REDACTED] at 0425 hours. [REDACTED] Inmate [REDACTED] After this [REDACTED] Inmate [REDACTED] was escorted back to confinement by Sergeant Canaday, Officers Hall, Lee and Robert Dale Fetter Jr. based on their sworn testimony and video, and upon entering confinement at approximately 0429 hours (camera time), video captured [REDACTED] Inmate [REDACTED] on Inmate [REDACTED] Inmate [REDACTED]

After leaving confinement, Officer Fetter began assisting with the escort of Inmate [REDACTED] After [REDACTED] Inmate [REDACTED] was [REDACTED] back to confinement by Sergeant Canaday, Officers Hall and Fetter. After [REDACTED] and upon entering the classification hallway, Sergeant Canaday, Officers Hall and Fetter began striking, punching, and kicking Inmate [REDACTED] on or about his body, and it was initiated by Sergeant Canaday. Inmate [REDACTED] after falling to his knees, was held by Officer Fetter while Sergeant Canady lined up his punches, and punched Inmate [REDACTED] in his rib cage multiple times. Sergeant Canaday, Officers Hall and Fetter were identified by Inmate [REDACTED] as being the staff who physically attacked him [REDACTED] that were later [REDACTED]. Inmate [REDACTED] acknowledged the battery continued after exiting the rear entrance of classification and that Officer Lee was present and witnessed this portion of him being battered behind classification, and failed to act or assist Inmate [REDACTED] but did not physically batter him.

Sergeant Donnie Davis testified while attempting to remove the restraints from Inmate [REDACTED] after assuming supervision of confinement on the morning of May 23, 2018, he discovered the restraints were applied so tight on the person of Inmate [REDACTED] Inmate [REDACTED] due to the restraints [REDACTED] Inmate [REDACTED] Inmate [REDACTED] was left in a holding cell in confinement for approximately three hours before the restraints were removed.

After alleging he was battered by staff, Inmate [REDACTED] was [REDACTED] who noted the following [REDACTED]

Your affiant respectfully submits, probable cause has been established in that, Sergeant Michael Canaday, Officer Travis Ian Hall, and Officer Robert Fetter Jr. did commit the criminal violation of; Malicious Battery of an Inmate §944.34(3)(a)(1), at Jefferson Correctional Institution in Monticello, Florida.
