Your affiant is Senior Law Enforcement Inspector Carrie Barcia of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that between August 1, 2018 and September 9, 2018, Dustin Johnson, a uniformed Correctional Officer, employed by the Florida Department of Corrections, did commit two counts of the criminal offense Sexual Misconduct, in violation of § FSS 944.35(3)(b) Florida Statute.

On September 9, 2018, a consensual search was conducted of Officer Johnson's vehicle that was parked on State of Florida property at Lowell Correctional Institution. During that search, a sexually explicit letter was recovered. The letter described in detail, a female performing oral sex on a man and a man performing oral sex and digital penetration on a female. The letter was handwritten and appeared to be from an inmate.

During a post-miranda interview conducted the same day, Officer Johnson identified the writer of the letter as Inmate [REDACTED] DC No. [REDACTED]. Officer Johnson admitted that the letter was to him, however, Officer Johnson denied that he was involved in a sexual relationship with Inmate [REDACTED].

On September 13, 2018, Correctional Officer Lieutenant Johnathan Kennison reported that he received information from Inmate [REDACTED] DC No. [REDACTED] that her [REDACTED] Inmate [REDACTED] was involved in a sexual relationship with Officer Johnson and that she had his DNA on one of her t-shirts. Correctional Officer Staff collected a t-shirt with a noticeable stain from Inmate [REDACTED] property and turned it over to the Office of the Inspector General.

Inmate [REDACTED] was interviewed by Lead Senior Inspector Jennifer Langston and Senior Inspector Carrie Barcia. Inmate [REDACTED] provided sworn testimony that [REDACTED]

Inmate [REDACTED] testified that [REDACTED]

Inmate [REDACTED] showed the shirt to her cellmate Inmate [REDACTED]. Inmate [REDACTED] then hid the shirt in her foot locker. The shirt was never washed.

Inmate [REDACTED] testified that [REDACTED]

Departmental Records indicate that Inmate [REDACTED] received a Disciplinary Report on September 9, 2018 for being in an unauthorized area. Inmate [REDACTED] was placed into Administrative Confinement. The narrative documented that Correctional Officer Nancy Earnest saw Inmate [REDACTED] enter I-Dormitory at approximately 11:45 AM. Officer Earnest had knowledge that Inmate [REDACTED] was assigned to [REDACTED] Dormitory and not supposed to be in I-Dormitory.

On January 24, 2019, the shirt found in Inmate [REDACTED] property was sent to the FDLE Laboratory for processing.

On April 4, 2019, the Office of the Inspector General was notified that semen was identified on the t-shirt and a complete male profile was obtained and would be suitable for comparisons.

On May 8, 2019, the Office of the Inspector General was notified that the DNA profile had been submitted to the CODIS system and a match occurred from a qualifying offender sample, who was identified Dustin Johnson.

Officer Johnson's last day of employment was September 12, 2018.

Inmate [REDACTED] was released from the Department of Corrections custody on [REDACTED] 2018.

Your affiant respectfully requests that a warrant be issued for the arrest of Former Correctional Officer Dustin Johnson for Two Counts of Sexual Misconduct, in violation of § FSS 944.35(3)(b) Florida Statute.
